*The Arizona Charitable Tax Credit can be taken in addition to credits for donating to public or private schools. When filing state taxes, report your donation on AZ Form 321. We prefer that you make your donations to Haven Totes by December 31, 2016 for our accounting but Arizona allows until April 15, 2017 to qualify for a tax credit for 2016. Any individual who files and pays Arizona income tax may be eligible for this tax credit. You may donate up to \$400 if filing as a single, or up to \$800 if filing taxes jointly. Your tax credit will be applied to reduce your tax liability, dollar-for-dollar. "Helping the working poor" tax credit is an actual credit off the amount you pay in state taxes. Consult your tax advisor.*

### "Assisting our Neighbors in Need"

As a "Qualifying Charitable Organization," **Haven Totes** is eligible to receive tax credit donations from Arizona taxpayers. Those who donate can assist neighbors in need and receive a dollar-for-dollar reduction in state tax liability. This "helping the working poor" tax credit is an actual credit off the amount you owe in state taxes.

Please consider making a tax credit donation to Haven Totes. We are a non-profit 501(c)(3), community outreach ministry that forms church partnerships to provide assistance to low-income children, families and seniors with food, new clothing and personal care supplies. We are an all-volunteer organization.

Many volunteers serve throughout the year to keep the "Totes for Kids" project running smoothly. This is a weekend feeding program for low-income school children living in Tucson. In addition, food boxes are distributed to families of "Tote Kids" several times during the year. Other volunteers work with the Senior Totes project, taking personal care supplies to low-income seniors during monthly visitations. Other individuals and businesses in our community have donated food, goods, and funds to support the efforts of Haven Totes.

All tax credit dollars which you donate will be used wisely to serve as many needy individuals as possible. A new bill, SB 1216, signed by Governor Ducey in May of this year, enables you to donate up to \$400 if filing AZ taxes as a single, or up to \$800 if you file jointly. You will use AZ tax form 321 when filing.

You may donate to Haven Totes, **in addition** to your favorite public or private school. We prefer that you make your donations to Haven Totes by December 31, 2016 for our accounting but Arizona allows until April 15, 2017 to qualify for a tax credit for 2016.
